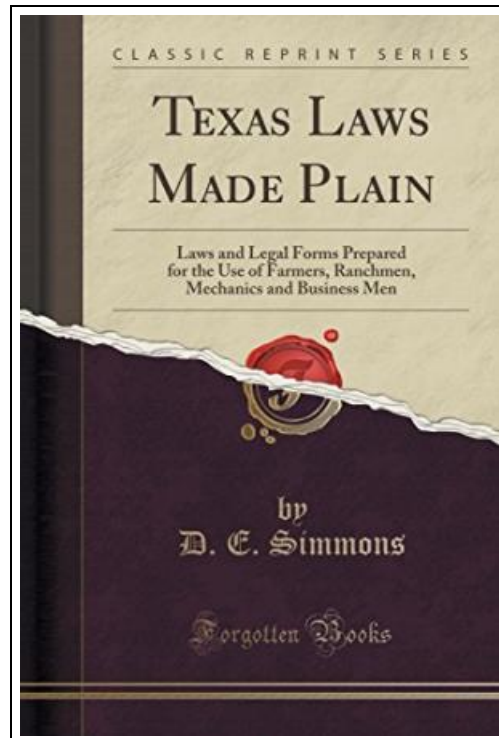

Brand New Book ***** Print on Demand *****.Excerpt from Texas Laws Made Plain: Laws and Legal Forms Prepared for the Use of Farmers, Ranchmen, Mechanics and Business Men The assignee, a resident of the county of the assignor or where his principal business was conducted, must make bond within five days, approved by the County Judge and filed with the county clerk; said bond conditioned that he will faithfully discharge his duties as such assignee, and properly distribute the estate among the creditors entitled thereto. Within thirty days he must give notice of his appointment by three weeks publication in a newspaper, in the county, (or if there be none, then in the nearest newspaper) and also notice, personally or by mail, to each of the creditors, who if he accepts, must do so In writing within four months, otherwise take no part in the distribution, and must, within six months from the first publication, file with the assignee a statement of the nature and amount of his claim supported by his affidavit or that of his agent or attorney, that same is true, that the debt is Just, and that there are no credits or offsets against the claim as therein shown. Fraud on the part of the assignor or assignee, or failure of the latter to make bond, will not invalidate the assignment, but it is the duty of the court to carry it out, by appointing a proper person to take charge of the estate and properly distribute it. If property has been fraudulently transferred prior to the assignment, or if the assignor left out of the inventory some of the property, the judge upon his own motion or the application...
