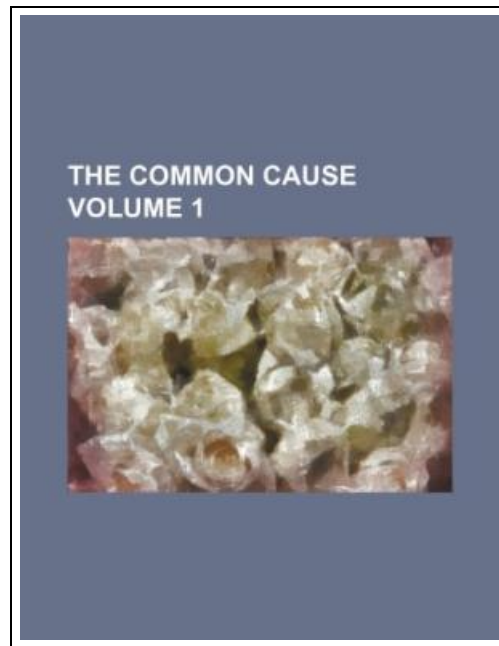

Professor Freund said that all legislative commissions appointed to investigate the matter favored the principle of compensation as distinguished from liability. He outlined the points involved in the principle of compensation as being: First--Payment for injuries or death, irrespective of fault or negligence except when caused by wilful misconduct. Second--The benefit payable bearing a definite relation to the former earning capacity. Third--The payment of the benefit in periodical installments, subject to commutation to a lump sum under specific conditions. Fourth--Denial of compensation for a brief initial period, in order to eliminate the great mass of insignificant injuries.-but liberal provision for medical treatment.
