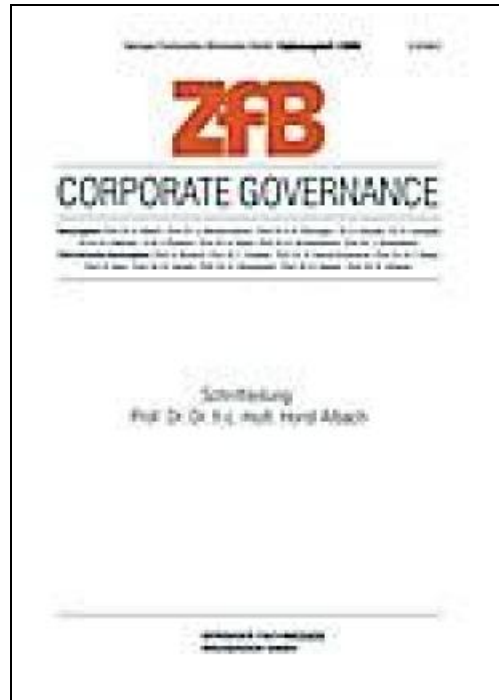

It points out how actors in the four fields of management follow each other as a result of evaluation procedures and the examples set by dominant players. Due to the dominance of American models in management education, research, and consulting the globalisation of management is, to a considerable extent, an Americanisation.
