

Concern about technology competitiveness may also be a factor in debate. For DOE s FY2003 Renewable Energy Program, the Bush Administration sought \$407.0 million, an \$11.3 million (3) increase relative to the FY2002 appropriation, not accounting for inflation. In the 107th Congress, the House Appropriations Committee recommended \$396.0 million for the FY2003 Program, which is \$11.0 million less than the request. In contrast, the Senate-passed version of the FY2003 Omnibus.
