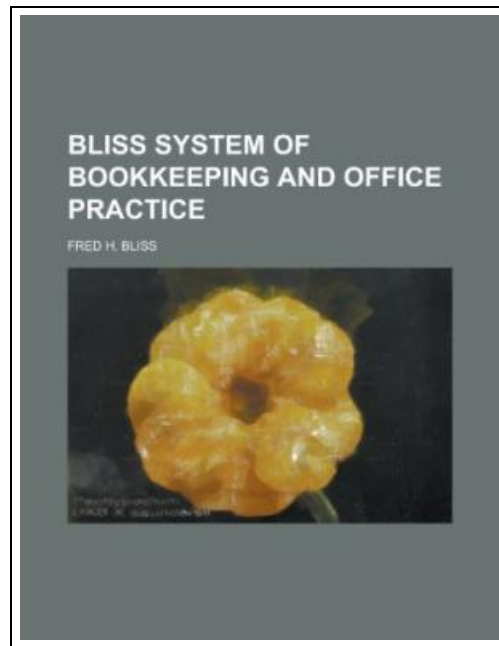

It is incumbent upon the attorney representing a plaintiff to get the facts straight before sending a threatening letter or filing a lawsuit, not after the letter is sent or the lawsuit is filed. Sadly, due in large part to the ineffectiveness of Rule 11 in its current form, we have a legal system in which many plaintiffs attorneys waste resources and...
