

OMB First, OMB Bulletin No. 01-02, Audit Requirements for Federal Financial Statements, dated October 16, 2000, prescribes specific language auditors should use when reporting on an agency systems substantial compliance with FFMIA. Specifically, this guidance calls for auditors to provide negative assurance when reporting on an agency systems FFMIA compliance. Second, in a January 4, 2001, Memorandum, Revised Implementation Guidance for the Federal Financial Management Improvement Act, OMB provided guidance for agencies and auditors to use in assessing substantial compliance.
