

This hearing of the Energy and Commerce Committee Subcommittee on Commerce, Consumer Protection and Competitiveness will come to order. I want to welcome everyone to today s hearing on Ncaa rules relating to payments to student athletes. Earlier this year I was troubled to read about the problems at Florida State University where a sports agent took several student athletes on a shopping spree for clothing and sports equipment. The incident reminded me of our first hearing over 3 years ago, when we heard members of the Knight Commission discuss how college sports were out of control. At that time, we heard testimony that more than half of the Division I-A schools, 57 out of 106 had been sanctioned or put on probation in the past 10 years. In the following years, the Ncaa and particularly college presidents have taken pride in their belief that they have reclaimed control over college sports, but the scandals keep coming. For example, the Auburn football program was sanctioned after allegations of loans and gifts from boosters were proven with the knowledge of the coaching staffs. Other schools, such as the University of Washington have been rocked by similar scandals. Nearly all of these cases revolve around money flowing illegally from either boosters or agents to student athletes. In some cases the amounts...
