

In other words, the captor, if duly commissioned, had a right, under the general principle, to carry his prize into the port of any nation at peace with France, without any other risk than being ordered to depart. The chief, and perhaps the only difficulty between Spain and the United States, in relation to these captures, was confined to a single fact, to wit: Whether France had embraced them in the satisfaction she made to the United States in the convention of 1800. If she had, Spain contended there could be no claim on her; if she had not, Spain admitted her liability. The United States took the position that France had, in that convention, made satisfaction only for the illegal or irregular acts committed in her own ports: and that no demand had been made on her for prizes carried into Spanish ports. The Spanish government produced On the 13th of November, 97, Victor Hughes and Le Bas, special agents to the Windward Islands, made the following decree: Several Americans hve escaped our vigilance, and that of the tribunal of commerce of Gaudaloupe. I/he.intention of government is to treat them with the severity that their treaty with our enemies has deserved: --decree, 1st. Every American who shall not have a register, sea letter, role d equipage, invoices and bills of lading; all in order and without contradiction,...
